Orders entered and acknowledged cannot be changed or modified without Symbiote’s written consent. Any subsequent change is subject to incurred costs and the ability to secure materials and labor. Symbiote reserves the right to increase the acknowledged price if such a change warrants any extra charge.
Before production starts, no cancellation charges will apply. After production starts, there is a 15% fee applied for the materials and products to be repurposed or modified for sale elsewhere. Orders of special or custom products, once production has been started, cannot be changed, or canceled without incurring up to 100% of the acknowledged price.
- 27. Restock of Merchandise:**
Our products are made-to-order, and therefore we generally do not accept returns. Requests for returns shall be considered on a case-by-case basis. Returns will not be accepted without prior written authorization. No Special or Custom product returns are allowed. Before returning any items, Agencies must notify the contractor, or authorized dealer, or contact Symbiote Project Operations directly and in writing via email at projectoperations@symbiote.com for RMA (Return Merchandise Authorization) along with shipping and labeling instructions. The returning agency is responsible for all packing and return freight charges. A restocking charge of 15% of the Net price is applicable for any product returned within 90 days, for other-than-warranty reasons, and requires that the product be in like-new-and-undamaged condition. No merchandise returns are allowed beyond 90 days. Damaged materials and build-to-order special or custom items cannot be returned under any conditions.
